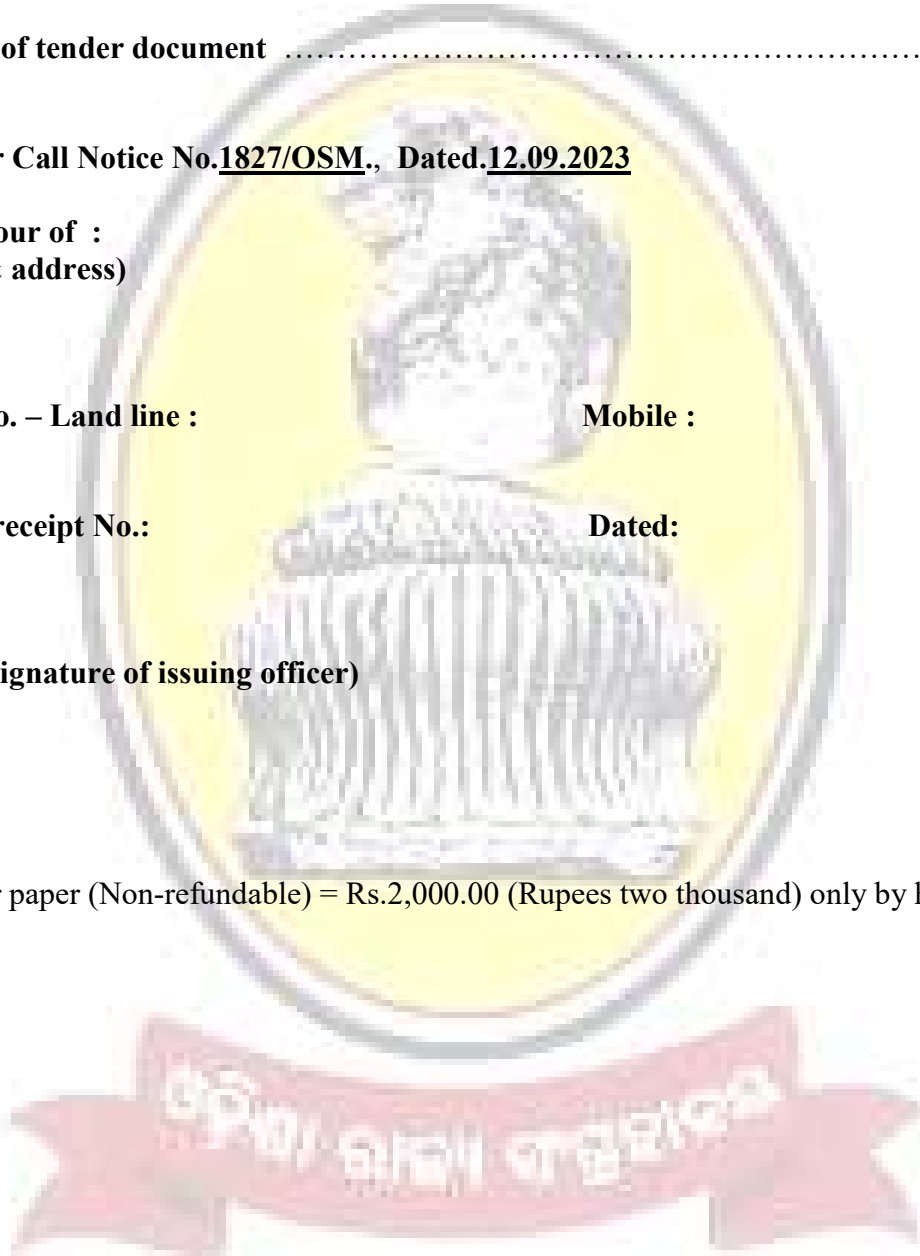

3. The tender must be dropped in the tender box kept in the office of the Superintendent, Odisha State Museum, Bhubaneswar on or before **21.09.2023** at **4.30 PM** . The bid is to be submitted in a single sealed cover superscribing “**Tender call Notice No.1827/OSM dated 12.09.2023** and the Bids will be opened **22.09.2023** at **3.00 P.M.** in the presence of the agencies, who may like to be present. If there will be a public holiday on the last date of receipt & opening of the tenders as specified above, the tender documents shall be received & opened on the next working day at the above time & venue.
4. Intending agencies are required to furnish the following documents in the Techno-Commercial Bid.
- Proof towards deposit of cost of tender paper
 - Annexure-I, II & III duly filled in
 - Copy of GST Registration Certificate
 - Copy of PAN card
 - EMD as above mentioned
5. The sealed tender duly filled in properly must be signed by the agency in each & every page as a token of acceptance of terms, conditions, specifications as laid down in the tender.

6. In case of production of forged document, the penalty shall be rejection of their tender. The authority reserves the right to verify the authenticity of documents in case of any doubt or complaint.
7. The tender received will remain valid for 90 (Ninety) days from the last date of receipt of tenders and the validity of tenders can also be extended if agreed to by the agencies and the Superintendent Odisha State Museum.
8. The agencies are required to furnish self attested copy of the dealership certificate for the products to be supplied and the system after successful installation should cover warranty for a period of 12 months for the date of installation.
9. Payment shall be released within 30 days from the date of successfully installation of the work.
