The bid is to be submitted in a single sealed cover superscribing "Tender Call Notice No.1290/OSM dated 21.06.2023 and the Bids will be opened in the office of the undersigned on 24.07.2023 at 11.30 A.M. in presence of the agencies, who may like to be present. If there will be a public holiday on the last date of receipt & opening of the tenders as specified above, the tender documents shall be received & opened on the next working day at the same time & venue.
- 5. Intending firms/agencies are required to furnish the following documents in the Techno-Commercial Bid.
