The bid is to be submitted in a single sealed cover superscribing **“Short Tender call Notice No.2292/OSM dated 17.11.2023** and the Bids will be opened **29.11.2023** at **3.00 P.M.** in the presence of the agencies, who may like to be present. If there will be a public holiday on the last date of receipt & opening of the tenders as specified above, the tender documents shall be received & opened on the next working day at the same time & venue.
4. Intending agencies are required to furnish the following documents in the Techno-Commercial Bid.
 - a. Proof towards deposit of cost of tender paper
 - b. Annexure-I, II & III duly filled in
 - c. Copy of GST Registration Certificate
 - d. Copy of PAN card
 - e. EMD as above mentioned
