- 3. The tender must be dropped in the tender box kept in the office of the Superintendent, Odisha State Museum, Bhubaneswar on or before 23.11.2023 at 12.30 PM. The bid is to be submitted in a single sealed cover superscribing "Short Tender call Notice No.2297 /OSM dated 17.11.2023 and the Bids will be opened 23.11.2023 at 3.30 P.M. in the presence of the agencies, who may like to be present. If there will be a public holiday on the last date of receipt & opening of the tenders as specified above, the tender documents shall be received & opened on the next working day at the same time & venue.
- 4. Intending agencies are required to furnish the following documents in the Techno-Commercial Bid.

 - b. Annexure-I, II & III duly filled in
 - c. Copy of GST Registration Certificate
 - d. Copy of PAN card
 - e. EMD as above mentioned
